### EDITORIAL CHARTER OF THE BLOG *African Integration Digest's*

#### 1. Aim

*African Integration Digest's* is the blog of the African Society of Community Law whose objective is to publish, in the form of posts, succinct and innovative analyses on issues of interest to African regional integration law.

#### 2. Themes

*African Integration Digest's* invites doctoral students, young researchers, established researchers and academics to propose for publication, original reflections on all fields of African regional integration law, in particular:

- legal monitoring of African international organizations;
- the jurisprudence of African community courts of justice;
- the impact of Community law on the economy and business;
- actors of Community law;
- the impact of national legislation on general integration;
- the challenges of regional integration at the level of regional economic communities.

These themes are indicative. Any submission concerning the activities of the African Society of Community Law will be examined with great interest.

#### 3. Instructions for authors

To be published, the post must:

- be original and not have been published in a magazine, on a website or on a blog;
- deal with a recent, current and relevant topic;
- be written with scientific and linguistic rigor;
- contribute to scientific research;
- contain at least **500** words and no more than **2000** words maximum, excluding summary and footnotes;
- include a summary of **100** words maximum, written in a language other than the one of the post itself;

- be written in one of the languages of the African Union: English, French, Arabic, Spanish, Portuguese or Swahili;
- integrate hyperlinks where appropriate.

### \* Citation method

Annotations and bibliographic references of in-text cited books and articles must be placed in footnotes.

Their presentation should be as follows:

- **for a book:** initial of the First Name, LAST NAME, Title of the book (in italics), publisher, date, page. Ex: **A. SALL, *La justice de l'intégration*, L'Harmattan, 2018, p. 125.**
- **for a journal article:** initial of First Name, LAST NAME, "Title of the article", Title of the journal (in italics), no., date, page. Ex: **S. BOUYAYACHEN, « La spécificité africaine du droit international des investissements : allégorie d'un paradigme régional de promotion des droits humains ? », *Annuaire africain des droits de l'homme*, 8/2024, p. 125.**
- **for a chapter in a collective book:** initial of First Name, LAST NAME, "Title of the chapter", in initial of First Name, LAST NAME, Title of the book (in italics), publisher, date, page. Ex: **P-C, KAMGAING, « L'avenir des communautés économiques régionales à l'aune de l'opérationnalisation de la ZLECAF », in A. SALL, *L'état du Droit communautaire en Afrique*, L'Harmattan, 2024, p. 342.**
- **for a website references:** initial of First Name, LAST NAME, "Title", Available from: URL, Accessed Day, Month, Year. Ex: **E. NKILI, "L'application inconstitutionnelle de la procédure civile au Cameroun", Available from: <https://www.village-justice.com/articles/application-inconstitutionnelle-procedure-civile-cameroun,44940.html>, Accessed 04 July 2024.**
