## **RULES OF THE AFRICAN INTEGRATION DIGEST'S BLOG**

### **Blog Managers and Blog Reviewers:**

- a) Two (02) Blog Managers are responsible for receiving, transmitting to review, acceptance or reject of the submission, publishing and laying out the posts on the LinkedIn platform, in particular with the titles and font and hyperlinks, etc.
- b) Ten (10) Blog Reviewers are in charge of proofreading (young researchers, doctoral students or confirmed researchers to encourage junior research aspect of the blog and monitoring).

### **Blog Coordinator**

One (1) *Blog coordinator* is designated to ensure the coordination of the Blog.

### **Mandates of Blog members**

The functions of Blog Coordinator, Blog Manager and Blog Reviewer are free. They are exercised for a renewable term of two (02) years.

The above functions are open to all ASCL members corresponding to any type of profile.

Female ASCL members are encouraged to serve in the above positions.

### **Designation of Blog members**

ASCL members are appointed to the positions of Blog Coordinator, Blog Manager and Blog Reviewer, following a free and transparent vote by their peers.

ASCL members propose to submit themselves voluntarily to the suffrage of their peers to exercise the above functions.
